Purpose. Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

Y N ☐ ☒ Statement of Housing Needs and Strategy for Addressing Housing Needs. ☐ ☒ Deconcentration and Other Policies that Govern Eligibility, Selection, and Admissions. FAMILY DEVELOPMENTS: HAN's developments were developed using HOPE VI funding with deconcentration of poverty as a primary consideration in their design and development. The developments - City Wide, Liberty, and Central Housing - consist primarily of one- and two-family units of varying bedroom sizes that are scattered throughout different neighborhoods within the City of Newport. With the exception of one development, these properties are mixed-finance developments with work requirements for admission and continued occupancy. The scattered-site design and distribution of the units throughout the City of Newport help promote housing choice and prevent a high concentration of assisted housing in any one neighborhood. Because HAN's units are distributed throughout the City and are not concentrated in a single neighborhood or geographic area, deconcentration is not considered an issue for these developments. ELDERLY DEVELOPMENTS: HAN currently operates three public housing developments designated primarily for elderly residents: Grand Towers, Corpus Christi, and Highland Village. All three developments are mixed-finance properties. Although Corpus Christi is located on the west side of Newport, an area that has historically had a higher concentration of lower-income households, HAN has not identified a significant income disparity among the elderly residents residing at Corpus Christi, Grand Towers, and Highland Village. The distribution of elderly housing across these developments does not result in a substantial concentration of lower-income elderly households in any one geographic area. Therefore, HAN does not consider deconcentration to be an issue among its elderly housing developments. HAN has established and will continue to implement procedures to evaluate all of its developments to promote an appropriate income mix among residents. HAN will administer all programs and activities in a fair and nondiscriminatory manner and in accordance with all applicable federal, state, and local laws and regulations. Prior to the beginning of each fiscal year, and in conjunction with the development of the Annual Agency Plan, HAN will analyze the income levels of families residing in each of its developments. Based on the results of this annual analysis, HAN will determine whether additional marketing, outreach, or other strategies are necessary to promote and maintain an appropriate income mix throughout its developments. HAN will monitor the effectiveness of any strategies implemented and will make adjustments as necessary to support balanced occupancy and continued housing opportunities for eligible families. ☒ ☐ Financial Resources. <u>Statement of Financial Resources</u> For fiscal year ending 2026, the HA anticipates receiving approximately \$1.1 million in PHA Operating Subsidy, and \$4.2 million in Section 8 Housing Assistance Payments funding. The HA anticipates over \$4.1 million in tenant revenue and approximately \$11,000 in fraud recovery. The Capital Fund Grant approved for 2026 totaled \$915,236. Through its nonprofit CHDO affiliate, Entryway, Inc., the HA received approximately \$291,664 in HOME funds for the restoration of three (3) homes for affordable homeownership. These homes are anticipated to be completed and sold in 2026/2027. NMHC III partnered with the Campbell County Fiscal Court for a \$996,526 CDBG Grant (2023) for the construction of seven (7) single-family homes for affordable homeownership opportunities. All homes have been completed and sold as of August 2026.

B.1	NMHC III partnered with the City of Newport for a \$994,000 CDBG Grant (2024) for the construction/rehabilitation of five (5) single family homes for affordable homeownership opportunities. These homes are anticipated to be completed and sold in 2026/2027. HAN, through these affiliates continues to seek funding for affordable housing opportunities. ☒ ☐ Rent Determination. <u>RENT DETERMINATION:</u> At admission and each year in preparation for their annual reexamination, each public housing family will be given the choice of having their rent determined under the income-based method or having their rent set at the applicable flat rent amount. Families who elect the flat rent will be required to complete the income reexamination process once every three years, rather than annually. Families paying flat rent may request an interim reexamination and return to the income-based rent method at any time if their income decreases or other circumstances change that may affect their ability to pay the flat rent. Except in cases of financial hardship, families may make only one rent election during each annual reexamination period. <u>Rent Determination- Income Method:</u> The total tenant payment is equal to the highest of: A. 10% of the family's monthly income; B. 30% of the family's adjusted monthly income; or C. If the family is receiving payments for welfare assistance from a public agency and a part of those payments, adjusted in accordance with the family's actual housing costs, is specifically designated by such agency to meet the family's housing costs, the portion of those payments which is so designated. If the family's welfare assistance is ratably reduced from the standard of need by applying a percentage, the amount calculated under this provision is the amount resulting from one application of the percentage; or D. The minimum rent of \$50.00 <u>Rent Determination - Flat Rent (Public Housing Only):</u> The HAN has established a flat rent for each public housing unit. In accordance with the HUD Appropriations Act of 2015, flat rents shall be established at no less than the lower of 80% of the applicable Fair Market Rent (FMR) or Small Area Fair Market Rent (SAFMR), as established by HUD for the Housing Authority's jurisdiction. The applicable flat rent shall be further adjusted, as appropriate, for tenant-paid utilities in accordance with HUD requirements. In no event shall the flat rent be established below 80% of the applicable FMR or SAFMR established by HUD, unless HUD suspends this requirement or revises its requirements to permit flat rents below 80% of FMR or SAFMR. Any increase in a family's rent resulting from an increase in the flat rent required by HUD shall be limited to 35% of the family's existing flat rent in any single year, unless applicable state or local law requires a lower increase. The HA continues to operate a Section 8 Homeownership program with three (3) participants. In FY 2015, the HA discontinued this program for new participants. The HA, through NMHC III, has and continues to partner with the City of Newport, as well as the Campbell County Fiscal Court, in seeking Community Development Block Grants (CDBG) and other funds for the construction and rehabilitation of homeownership units for low- to moderate-income families. The City was awarded \$994,000 in the 2024 CDBG funding round for the construction/rehabilitation of five (5) single-family homes to be sold to families at or below 80% Area Median Income. These homes are anticipated to be completed and sold in 2026/2027. The HA also received approval from the Campbell County Fiscal Court for 2023 CDBG Grant funding of \$996,526 for the construction/rehabilitation of an additional seven (7) homes. Five (5) of these homes would be new construction and the remaining two (2) would be rehabs. These homes are to be sold to families at or below 80% Area Median Income (AMI). All homes have been sold as of August 2026. The HA, in partnership with CHDO and Entryway, was awarded \$291,664 through the Covington HOME Consortium for the rehabilitation of three (3) homes to be made available for purchase by homebuyers earning up to 80% AMI. To date, one home has been sold, one home has been completed and has a potential buyer, and the third home is anticipated to be completed in 2026. All homes are expected to be sold in 2026/2027. The HA anticipates applying for funding through the Covington HOME Consortium for the development of an additional four (4) single-family homes to be sold to qualified homebuyers earning up to 80% AMI. Of the four (4) homes, three (3) will be newly constructed and one (1) will be rehabilitated. These homes are expected to be completed in 2027/2028. NMHC III, through its partnership with the Campbell County Fiscal Court, expects to submit an application for the next round of CDBG Grant funding for the construction of five (5) single-family homes. These homes are to be sold to families at or below 80% AMI. The HA will continue to seek funding to construct/rehabilitate affordable homes for sale to low- and moderate-income families.

The HA works with area social service agencies and families who are victims of domestic violence as needed. The HA continues to work closely with local law enforcement agencies for the prevention and identification of criminal activity within its developments. B.2	New Activities. (a) Does the PHA intend to undertake any new activities related to the following in the PHA's current Fiscal Year? The HA, through NMHC III, has and continues to partner with the City of Newport, as well as the Campbell County Fiscal Court, in seeking Community Development Block Grants (CDBG) and other funds for the construction and rehabilitation of homeownership units for low- to moderate-income families. The City was awarded \$994,000 in the 2024 CDBG funding round for the construction/rehabilitation of five (5) single-family homes to be sold to families at or below 80% Area Median Income. These homes are anticipated to be completed and sold in 2026/2027. The HA also received approval from the Campbell County Fiscal Court for 2023 CDBG Grant funding of \$996,526 for the construction/rehabilitation of an additional seven (7) homes. Five (5) of these homes would be new construction and the remaining two (2) would be rehabs. These homes are to be sold to families at or below 80% Area Median Income. All homes have been completed and sold as of August 2026. The HA, in partnership with CHDO and Entryway, was awarded \$291,664 through the Covington HOME Consortium for the rehabilitation of three (3) homes to be made available for purchase by homebuyers earning up to 80% AMI. B.2	The HA anticipates applying for funding through the Covington HOME Consortium for the development of an additional four (4) single-family homes to be sold to qualified homebuyers earning up to 80% AMI. Of the four (4) homes, three (3) will be newly constructed and one (1) will be rehabilitated. These homes are anticipated to be completed in 2027/2028. NMHC III, through its partnership with the Campbell County Fiscal Court, expects to submit an application for the next round of CDBG Grant funding for the construction of five (5) single-family homes. These homes are to be sold to families at or below 80% AMI. The HA received HUD approval in July 2024 for the use of Capital Funds for the construction of four (4) one-bedroom Public Housing rental units for individuals with household incomes at or below 80% AMI. Construction of all four (4) units has been completed, and all units were fully occupied as of March 2026. The HA expects to continue seeking HUD approval to utilize funds for the construction/rehabilitation of single-family homes for homeownership. The HA also expects to utilize PBV Vouchers and/or other HUD funding, including Capital Funds, DDTF Funds, Operating and Operating Reserve Funds, or site sales dollars for the construction of two multi-unit buildings to contain up to four (4) one-bedroom rental units (each) for individuals with household incomes at or below 80% AMI. The HA also intends to apply for Neighborhood Homes Investment Credit (NHIC) funds and/or other funding, including HOME funds, Low Income Housing Tax Credit (LIHTC) funds, and Tax-Exempt Bonds. These funds, if approved, would provide a funding gap for developers constructing/rehabilitating homes in distressed neighborhoods. These funds would likely be administered under the LIHTC rules, and as such, qualified buyers would be restricted to specific income levels. The HA also expects to utilize these funds, if approved, for the construction of additional multi-unit buildings for PBV Vouchers for VASH or Senior Affordable Housing. ☒ ☐ Demolition and/or Disposition. The HA received HUD Approval in July 2015 for the disposition and demolition of the Peter G Noll site, consisting of 173 units. As of June 30th, 2017, all residents have been relocated from this site, and all of the buildings have been demolished. Part of the parcel has been deeded to the City of Newport for replacement of a park that existed on the site now occupied by the Northern KY Scholar House. The HA intends to request HUD approval to dispose of all or a portion of the remaining parcel that has not yet been approved for disposition. The Kentucky Transportation Cabinet (KYTC) expressed interest in acquiring a portion of the Peter G Noll site in connection with the construction of the 4th Street replacement bridge. As a result of the eminent domain action, the HA and KYTC reached a settlement agreement in the amount of \$1,861,900. The HA intends to use the \$1,861,900 in settlement proceeds to facilitate the development of affordable rental housing units subsidized through Housing Choice Vouchers and to support additional homeownership development through its nonprofit affiliate, NMHC III. The HA will finalize such plans for submission to HUD in its 5-year plan and annual plan. The HA also intends to submit a disposition application for some of its public housing units. Specifically, several single- and two-family units in the current portfolio are not cost-effective to manage, both from an operational and maintenance standpoint. The HA may replace some of these public housing units by constructing new housing, including one or more multi-unit or single-family buildings which will consist of one-bedroom units.
